These monies have been combined with annual resources from U.S. Department of Education post-Sputnik programs, originally labeled the "Eisenhower" program, and now No Child Left Behind (NCLB). LaSIP's signature effort has been statewide university-based Science, Technology, Engineering and Mathematics (STEM) professional development for K-12 teachers. Currently, approximately \$1.5 million annually allocated to the Board of Regents through NCLB is available for LaSIP. Federal regulations require that these dollars be competitively awarded to university-based professional development projects for K-12 teachers.
